**The purpose of Amendment 01 to RFP J058932/A to answer questions from Industry.**

**Question 1:** On page 12: The Bidder must demonstrate that since April 1, 2018, he or she has acquired at least **10,000 hours** of experience teaching English as a second language to groups of at least four adult students. Would there be any possibility to amend the starting year to 2015?

**Answer 1 :** We grant a change in the starting year, for **April 1, 2016**. This is the number of hours of experience for the company. We consider that 6 years (April 2016 to April 2022) are sufficient to demonstrate experience in the field, as well as the bidder's capacity to meet the client's needs, considering that our current requests can go up to 4 full-time teaching resources.
