- Q4 Item a) under the heading "For Proposed Resources", the solicitation states "experience gained through formal education will not be considered as experience". We would like to clarify the meaning of "formal education". In particular, we would like to clarify whether research work done as part of completing the thesis/dissertation requirements of a master's/PhD degree counts as experience for this solicitation? Further, we would like to highlight that if this type of experience is excluded, then under the definitions of section 11.2, essential no graduate students or postdoctoral fellows would be allowed to work on tasks associated with this solicitation.
- A4 That is correct. Only students who have received compensation for work relevant to that identified in the RFP would be deemed acceptable to work on tasks associated with this solicitation.

- Q5 We would like to clarify potential discrepancies between Annex B and Attachment 1. "Annex B-Basis of Payment" lists the categories: 1) Labour; 2) Supporting Costs; 2.1) Equipment; 2.2) Materials & Supplies; 2.3) Subcontracts; 3) Tavel & Living Expenses; 4) Price Breakdown for Task Authorizations. On the other hand "Attachment 1" only asks for the specification of the Labour rates.
 - We would like to confirm that the only costs to be listed in the financial bid are the Labour rates, i.e., the tables defined under sections 1 and 2 of the Attachment 1? That is, we should not include any values for, e.g., Equipment or Travel in the current bid?
- A5 That is correct. Without knowing what the tasks are, you cannot accurately determine the need for or the cost of any other element. Those costs are defined at the time of Task Authorization.
 - It is recommended that you also review 2040 General Conditions Research and Development, section 05 Conduct of the Work, sub-section 1. Canada will pay for equipment delivered under the contract, and consumable materials and supplies. The Supply Manual, Chapter 10, Cost and Profit is also a good resource and can be found on the buyandsell.gc.ca website.

- Q6 The tables defined under sections 1 and 2 of the Attachment 1 include column E & M "Estimated Level of Effort (Hours)". We would like to confirm that we are to use the numbers already populated in this table in the solicitation in calculating columns F & N. For instance, we should use the value of 440 in calculating the cost of Senior Researchers in the initial period?
- A6 That is correct. It is understood that more than one resource may be required in the performance of the work.
