4.1.2 Financial Evaluation

4.2.1 Mandatory Financial Criteria

The Bidder must submit firm lot or unit prices for all items in accordance with Annex B, in Canadian currency, Harmonized Sales Taxes are excluded.

4.2.1 Financial Evaluation

The bidder's unit pricing for each resource will be multiplied by the estimated usage to calculate the extended pricing for each line item. The evaluated price will be the sum of the lot price in Pricing Basis "A" and extended pricing for all line items in Pricing Basis "B". Disbursements for vessel fuel will not be included in this calculation.

4.3 Basis of Selection

4.3.1 Basis of Selection - Firm Requirement, Mandatory Criteria

A bid must comply with the requirements of the bid solicitation and meet all mandatory technical and financial evaluation criteria to be declared compliant. The compliant bidder who has the lowest Evaluated Price in Canadian currency will be recommended for contract award.

4.2.1 Mandatory Financial Criteria

The Bidder must submit firm lot or unit prices for A1. or A2.nd all items in Pricing Basis "B" in accordance with Annex B, in Canadian currency, Harmonized Sales Taxes are excluded.

4.2.1 Financial Evaluation

The bidder's unit pricing for each item in pricing Basis "B" will be multiplied by the estimated usage to calculate the extended pricing for each line item. Canada's preference is to award a contract for the term from June 12 to 24, 2022. The Evaluated Price will be the sum of the lot price for A2 and the extended pricing for all line items in Pricing Basis "B". If no bidders can provide a support vessel from June 12 to 24 (lot price A2) then the term from June 12 to 22 (lot price A1.) will be added to the extended pricing for Pricing Basis "B" to calculate the Evaluated Price. Disbursements for vessel fuel will not be included in the calculation of the Evaluated Price.
