9	Is an embassy in Canada considered to be within Canada or international? Technically, the embassy properties are not Canadian territory.	Canada, while embassies benefit from certain exemptions and immunities that flow from the Vienna Conventions on Diplomatic and Consular Relations, they constitute real property/immovables that are subject to local property laws.
10	Page 29, item P4 shows 3 points for BOMA and 3 points for Green certification – but the maximum total number of points is shown as 3 – rather than 6. Is this intentional?	Yes, this is intentional, a maximum 3 points per project are available for P4.
11	Page 30, item P7 shows a maximum of 2 points per project, however there is the possibility of 3 available points.	This is intentional, a maximum 2 points per project are available for P7.
12	On page 4 of the RFP, PWGSC states that the local firm would be a sub-consultant. As a sub-consultant, the local partner would not be able to stamp/seal the contract documents. Are the drawings intended to be stamped by the Canadian Architect for submission to the city of Dakar?	Canada intends to award one AES contract to a firm. The Respondent may partner or engage with a local firm to meet local requirements . Refer to page 4, section 1.1, third paragraph.
13	Could PWGSC please clarify if there is a typo in the proposed schedule on page 5 of the RFQ? Our understanding of the project scope is that contract documents would be completed in December 2023 (rather than 2022) and construction contract award in January 2024 (rather than 2023).	Yes, refer to document change no.3.
14	Could PWGSC please clarify accepted reference project typology as described in the 'Definitions for Respondents'? Would PWGSC accept 'BOMA Class A or equivalent' projects, including healthcare, high rise residential, etc.	Refer to Annex D, BOMA Class A definition in the document.
15	Could PWGSC please clarify under the definition of 'international' on page 25 of the RFP, that the satellite offices of a multinational firm and the office in the "international" country are the same?	No - see the definition of "International" in Annex "D"
16	What is Canada's definition of a client under Annex F, particularly in terms of the signature requirement within Section B?	Canada defines the client as a representative within the organization that received the services.
