“Amendment 003”

Solicitation amendment **003** is raised to **1)** provide questions and answers and **2)** amend the Invitation to Qualify (ITQ) accordingly.

1) Questions and Answers:

Further to the clarification of the requirement in Form 3, Qualification Requirement, of Annex C that was provided under amendment 001:

“List of all Configuration Items (CI) defining the Vehicle Baseline Configuration of the proposed Combat Variant of a Fighting Vehicle. This information must be provided as a separate document attached to the ITQ response in a format compatible with Microsoft Excel.”

Q7. Can Canada confirm that a complete list of all Configuration Items is required for the ITQ.

The requirement to list all the Configuration Items introduced at amendment 001 will be replaced as it would otherwise generate a surplus of information that is not necessary for the ITQ. Canada’s intent as per section 1.3.2 of the ITQ, is for industry to demonstrate that the proposed configuration at RFP is the same configuration qualified at ITQ.

2) Amend the ITQ accordingly:

In Form 3, Qualification Requirements, of Annex C, Response Submission Forms, amend the proof of compliance requirement as follows:



information beyond this minimum requirement may exist in the OEM Configuration Management System but is not required for the ITQ. This information must be provided as a separate document attached to the ITQ response in a format compatible with Microsoft Excel.”



Note 1: The vehicle OEM CM system could detail any number of additional major systems; This information is not required for the ITQ.
Note 2: The vehicle OEM CM system could detail any number of additional level 2 CI components, and / or any level of details for breakdown of level 2 component into lower level components. This information is not required for the ITQ.
