#### **QUESTIONS AND ANSWERS:**

Question 1	Page 12/22 2.Firm Goods The price grid shows only line items related to the
	equipment. There is no mention of the costs for the CDRL deliverables. Are the bidders
	to add these to the chart, or are you assuming the cost of the CDRLs will be amortized
	over the cost of the goods? Please advise.
Answer 1	CDRL deliverables (i.e. DID) are not to be costed seperately. The cost of CDRL deliverables (i.e. DID) are to be included in the cost of the various Tool Kit.
Question 2	Page 18/22 6.7.2 Hold Back: This clause imposes a 10% Hold back which is "to be
	released upon receipt and certified acceptance of the Work". You have not provided a
	procedure explaining exactly how these approvals are to be "Certified", nor who the
	approval authority is. The 10% withholding is typically applied when there is an
	overriding risk to the Crown regarding non-performance post-delivery. Further these
	are deliverable line items with Gov't net 30-day payment terms, which the Crown will
	typically delay in the event of a discepancy. We are failing to see the necessity for the
	10% withholding. We would like to understand the reason for the withholding and
	further the Crown should provide the detailed procedure as to exactly how the
	acceptance is to be done and who the approval authority is, especially as there is no
	requirement for the DND QAR approval of any of the deliverables.
Answer 2	The holdback are to be applied on any payment due in regards to the various Tool Kits upon receipt and acceptance of all Work under this Contract which includes all CDRL deliverables (i.e. DID). Inspection and acceptance of all goods and services under this contract are in accordance with Article 6.13.

Question 3	Would the Crown consider a phased delivery of the tools, allowing the contractor to ship the tools when they become available, and not holding up the deliveries until the very last tool is received?
Answer 3	Yes, multiple deliveries will be accepted.
Question 4	We have not yet received the answer to our below noted inquiries. Also today we have submitted an additional request for clarification. At this point we would like to request a two week extension to the closing date.
Answer 4	A two week extension is being issued.
Question 5	As per the bid # W8476226527/A it specifies needs to be shipped as a Kit does this mean we package 10 tools and accessories all in one plate ground tools and underwater tools. Or can we ship as it comes in?
Answer 5	Each Ground tools (10 tools) kit must be packaged and shipped as a kit together and same with the underwater tool (8 tools) kit must packaged and shipped as a kit together.
