1. QUESTIONS AND ANSWERS

- Q1:** Could PCO confirm if there has been an incumbent within twelve months (or greater)?
- A1:** The work that is to be done under the resulting contract from this solicitation was previously handled under a contract issued by PSPC on the behalf of TBS with Qualtrics. PCO had an agreement with TBS to cover its services under this contract.
- Q2:** To help industry properly assess this requirement, could PCO confirm the budget for this requirement?
- A2:** The total budget currently allocated to this requirement (including option years) is \$750,000 without taxes.
- Q3:** For R2, could PCO confirm if bullets 2 and 3 are sub-bullets under bullet 1?
- A3:** The latter two bullets are sub-bullets of the first. We are looking for three examples of each of those two sub-bullets (6 examples total).
