NOTICE TO INDUSTRY

This notice has been published as a follow-up to Request for Information (RFI) #5A090-213802/A (which closed on September 24, 2021), the follow-on engagement meetings that occurred in November 2021 and #5A090-213802/B (which closed on February 28, 2022). The purpose of this notice is to provide transparency with respect to a Respondent question raised that could be of interest to other members of industry.

Any further questions with respect to Indigenous Services Canada's (ISC) Remote, Isolated, and Semi-Isolated First Nations Nursing Services requirement will be answered through the formal channels detailed within any future solicitation issued in relation to the requirement.

QUESTIONS AND ANSWERS

Question 1:

In notice 5A090-213802/B, question and answer #1, it states that Canada anticipates issuing an RFI containing a draft RFP for industry comment/feedback in spring 2022. Is the RFI still expected to be released or will the procurement process be going directly to an RFP in the Late Summer/Fall?

Answer 1:

In order to adhere to the procurement timeline Canada no longer intends on issuing an RFI in spring 2022. It is now anticipated that the next step of the procurement process will be issuance of a competitive RFP in late summer/fall 2022.
