The purpose of this amendment is to:

1. Extend the closing date of the solicitation by two weeks from June 3rd 2022 to June 17th 2022 at 2:00PM EDT.

All other terms and conditions of the RFSO remain unchanged.

Bidders' Questions Received as of May 18th 2022.

- Q1. 3.1 - Submit by Fax: Q. what is meant by " offerors provide separately bound sections". Does this mean that each section is sent in a separate fax?.
- A1. For submissions by fax, submissions do not need to be in separately bound sections. Sections must be separated by a cover page to aid in separating the financial and technical bids.
- Q2. Chose to send submission by facsimile: Q. By this you mean to send by regular fax to a fax phone number but I did not see any fax phone number to send it to, will one be provided?
- A2. Submissions by Fax must be made to the fax number shown for the bid receiving unit in the top left corner of the RFSO cover page. The number is (819) 997-9776.
- Q3. Also there is mention of a soft copy in the sent by fax section, if we are sending by fax, a soft copy cannot be sent over fax. Should this be ignored?
- A3. That is correct. Soft copy is not a requirement of submission by fax.
- Q4. 3.1.2 - Exchange rate fluctuation: Q. What does C3011T represent?
- A4. C3011T Can be found in the SACC manual here: <https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual/5/C/C3011T/5>. C3011T does not offer exchange rate mitigation.
- Q5. 5.1.1 – Integrity provisions: Q. if there are no offences to be declared must we complete this document and submit?
- A5. If there are no offenses to declare this form is not required.
- Q6. Part 6 – 6.1 – 1 – a: There is a requirement to have a valid organisation security clearance. Is this a requirement given that 7.2.1 states there is no security requirement?
- A6. The security requirements in 7.2.1 supersede the instructions in 6.1. There is no security requirement.

- Q7. Pricing matrix: in the last RFSO we were required to give separate pricing for year 1,2,3 as well as individual pricing for 3 different quantities and there was a clause allowing us to increase prices according to inflation (consumer price index) in year 4 and 5 which was allowed in the last SO. There is no mention of either of these so you are asking for a fixed price for any quantity for the 3 year plus 2 year option, is that correct?
- A7. Canada is looking for a single firm fixed price for each item for the duration of the standing offer.
