Question 89:

Reference: Revised 004_english_attachment_3_-_pricing_tables, Acquisition tab, Table 2 - Optional JTAC VTS Acquisition Requirements; Line 24, Delivery and Installation

Based on the Quantity for this item, it appears that Canada expects to see pricing for delivery and installation of the portable systems because the quantity matches the quantity for the portable systems.

Prices for delivery and installation for portable systems are typically lower than for a static system.

- a) We are assuming that the delivery and installation line item in table 2 is for a portable system. Is that correct?
- b) Does the Government want to add a line for delivery and installation for a static system in table 2?

Answer 89:

Canada requires pricing for the delivery and installation of both static & Portable system.

Question 90:

Does a foreign company have to be registered in the Supplier Registration Information (SRI) system and obtain a Procurement Business Number (PBN) in order to bid?

Answer 90:

No, Bidders do not have to be registered or have a Procurement Business Number (PBN) in order to bid.

Question 91:

Reference: Dimensions - the system shall be used indoors in standard training facilities. The static system shall operate in a space of 14 meters by 8 meters with a maximum ceiling height of 3 meters.

Section: Technical A1.14.1, A1.14.2, A1.14.3, and A1.14.4

We can provide a display solution that meets all of the A1.14.1, A1.14.2, A1.14.3, and A1.14.4 requirements in both the "must" and "should" categories as stated in the JTAC VTS RFP, Annex A page A -89 / 230.

However, the IFFS footprint requirements of the available space, provided in **Amendment 4, Appendix 1-4/20 does not permit** a system of 270 horizontal field of view and 100 (-30/+70) vertical field of view to fit within the facility constraints which are described as the "should" requirements of the JTAC VTS projection system. Those facility constraints are described as: "Dimensions - the system shall be used indoors in standard training facilities. The static system shall operate in a space of 14 meters by 8 meters **with a maximum ceiling height of 3 meters;**".

Are the A1.14.3 and A1.14.4 requirements incorrect, or is the room height larger than 3-meters?

Answer 91:

Yes, please refer to RFP solicitation amendment 004 since all of these measurements are the correct ones. In addition, the winning bidder will have the opportunity of conducting a site visit.

Question 92:

Both Volume 1: Joint Terminal Attack Controller Virtual Training System RFP & Volume 2: - Joint Terminal Attack Controller Virtual Training System In Service Support Services contain the exact same Annex's' s (ex. Annex D - Electronic Payment Instruments, Annex E - Federal Contractor's Program for Employment Equity - Certification, Annex F - COVID Vaccination Requirement Certification) which are required with Bid submission.

Since the same document is contained in both Volumes can the Government confirm bidder only needs to complete one (1) of these to submit with their bid?

Answer 92:
