Title: Office Furniture, Category 2, 3 & 5

(1) This solicitation is hereby amended to provide the following questions and answers:

Q11: Referencing Amd 001, Q7/A7: Furniture manufacturers do not manufacture the digital lock technology, therefore all manufacturers would have access to the same third party digital locks available in the industry. Can you please confirm that all locks are to be operable by RFID, and that RFID locks will be the only acceptable option to be provided? Also can you please confirm if you will require 389 RFID cards to operate these locks, or will they be operated by use of a smart phone?

A11: As per Q7/A7 The lockers should come equipped keyless locking mechanism as part of GOCUID 3LSL1HXXPM12D20XHXS. While RFID locks are the preferred locking mechanism, where RFID is not available and numeric pads are utilised, consider brail along with printed numbers. If the keyless built in RFID locks are used, then we would require 389 RFID cards to operate the locks.
