Bidders' Questions and Responses from Canada

Question 1: We don't have any trained actors who are fluent in Arabic.

Response: The Bidder having Arabic speaking actors is not a mandatory requirement and will not be evaluated.

Question 2: Your security check list item 6a states that the Bidder and its employees will require access to protected or classified information. This is not correct. We operate as an agency with about 80 actors under contract. We provide only the commercial administration of our contracts and are not involved in the training.

Response 2: The Contractor and their employees or subcontractors must have a security clearance in accordance with clause 7.3.1 to be awarded this contract.

Question 3: Annex B, Pricing, years 2 and 3 cover two years and overlap?

Response 3: That was a typo and it is corrected in this amendment.

Question 4: Annex B, Pricing, estimates travel, meals and accommodation at \$25,000.00 per year. For contracts of similar size this amount has been about \$40,000.00 per year.

Response 4: This is only an estimate and it is not included in the evaluation. If more funds are required they will be added.

Question 5: [The requirement asks specifically for Theater training. Would Film experience be also accepted as meeting the requirements?](#)

Response 5: [In reviewing the description of film experience, I would agree that film experience would be accepted.](#)

Question 6: [The requirements are for Theater actors. Since this is similar to or the same as Scenario Based Training \(SBT\), and in SBT, there are many different scenarios \(Acting Roles with multiple levels of behaviors required for the same scenario often as defined by the instructor\), will Canada accept Scenario Based Training experience as an acceptable equivalent?](#)

Response 6: [In reviewing the definition of SBT, SBT experience would be an acceptable equivalent.](#)

Response 7: [Acting experience over a 5 year period. It can be seasonal as described from the potential bidder; it doesn't have to be full-time throughout the year.](#)

Question 8: All of our actors are subcontractors. We can't get insurance to cover them. Can you remove the insurance requirements?

Response 8: Yes. The actors will need to carry their own insurance.

PART 6 - SECURITY, FINANCIAL AND OTHER REQUIREMENTS

6.2 Insurance Requirements

The Bidder must provide a letter from an insurance broker or an insurance company licensed to operate in Canada stating that the Bidder, if awarded a contract as a result of the bid solicitation, can be insured in accordance with the Insurance Requirements specified in Annex "C".

If the information is not provided in the bid, the Contracting Authority will so inform the Bidder and provide the Bidder with a time frame within which to meet the requirement. Failure to comply with the request of the Contracting Authority and meet the requirement within that time period will render the bid non-responsive.

Delete:

7.14 Insurance – Specific Requirements

The Contractor must comply with the insurance requirements specified in Annex "C". The Contractor must maintain the required insurance coverage for the duration of the Contract. Compliance with the insurance requirements does not release the Contractor from or reduce its liability under the Contract.

The Contractor is responsible for deciding if additional insurance coverage is necessary to fulfill its obligation under the Contract and to ensure compliance with any applicable law. Any additional insurance coverage is at the Contractor's expense, and for its own benefit and protection.

The Contractor must forward to the Contracting Authority within ten (10) days after the date of award of the Contract, a Certificate of Insurance evidencing the insurance coverage and confirming that the insurance policy complying with the requirements is in force. For Canadian-based Contractors, coverage must be placed with an Insurer licensed to carry out business in Canada, however, for Foreign-based Contractors, coverage must be placed with an Insurer with an A.M. Best Rating no less than "A-". The Contractor must, if requested by the Contracting Authority, forward to Canada a certified true copy of all applicable insurance policies.

Insert:

Insurance - No Specific Requirement

The Contractor is responsible for deciding if insurance coverage is necessary to fulfill its obligation under the Contract and to ensure compliance with any applicable law. Any insurance acquired or maintained by the Contractor is at its own expense and for its own benefit and protection. It does not release the Contractor from or reduce its liability under the Contract.
