### Amendment 001

This amendment is raised to answer questions from bidders.

#### A. Questions and Answers

1. Is Parks Canada Agency amenable to sharing the historical value of this contract for the last 12 months?

**Answer:** The contract value in 2021 was \$67,713.68 (before taxes) **for one year only**. However, it should be noted that the contract value was higher due to a very different statement of work than the one currently posted. The previous statement of work had more tasks and additional requirements related to the COVID-19 pandemic.

2. Can you please share with us the square footage of the Cap-de-Bon-Desir Interpretation and Observation Centre as well as the Marine Environment Discovery Centre so as to assist us in providing the best pricing to Parks Canada Agency.

**Answer:** The dimensions of the main buildings at the Cap-de-Bon-Désire Interpretation and Observation Centre are as follows: janitor's house 839 square feet, assistant janitor's house 904 square feet, and toilet block 365 square feet. The main building of the Marine Environment Discovery Centre is 4445.5 square feet.

3. Is Parks Canada Agency amenable to extending the deadline for this tender to assist proponents in preparing the most comprehensive responses?

**Answer:** No.
