This amendment is raised to answer bidder's questions.

QUESTIONS AND ANSWERS

Question # 12

We wish to pose the following question for ESDC G9292-217754/A:

RE: RTC2

We wish to clarify the RTC2 where it states: *"For the purpose of this criterion, a single resource is defined as one position for that resource category which multiple individuals may fill, but not simultaneously."*

For this requirement, please confirm that the following, on one contract, would score 10 points:

Resource A, Technology Architect, worked May 2019 – April 2020 for a total of 220 days

Resource B, Technology Architect, worked January 2020 – October 2020 for a total of 120 days but only counting 100 days worked between May 2020 and October 2020

Resource C, Technology Architect, worked September 2020 – October 2021 for a total of 260 days but only counting 220 days worked between November 2020 and October 2021

In total, three different resources, in the same resource category, worked 540 days.

Response #12: Confirmed. The Bidder would receive 10 points.

***Note: The Bidder must clearly indicate the date range of the billed days being claimed. For resource B, in the example above, the Bidder would specify in the bid the date range from May 2020 to October 2020 for the 100 billed days being claimed. Similarly, for resource C the Bidder would specify in the bid the date range from November 2020 to October 2021 for the 220 billed days being claimed.
