**QUESTIONS AND ANSWERS**

Question 1:

Will Canada accept an alternate product equivalent to the Surefire M300C?

Answer 1:

The RCMP cannot accept equivalent products to the Surefire M300C light. This light is currently installed on RCMP operational firearms with a high volume already in service. For officer safety, gun accessories must be kept identical whenever possible due to muscle memory and training. To change the light would also result in additional expenditures as the light is positioned in a specific location via the use of an alternate offset mount to both improve manipulation of the lights activation switch as well as positioning the accessory to be compatible with other operational requirements (i.e., in-vehicle weapon rack, additional accessories on the rifles, ambidextrous or specific operator positioning requirements, training, etc.).
