- 1.2 QUESTIONS AND ANSWERS:

Question 1	Is the end date March 31 2023?
Answer 1	<i>Transport Canada has asked that the analysis be performed on the year 2021 (when data is available) or on the most recent year, depending on the dataset.</i>

Question 2	The due date for the draft final report 20 days before the end of contract period may not allow sufficient time to translate the report to French. What does TC do to mitigate the time for French translation ? for example will they guarantee a five day turn time regarding their comments in order to facilitate the French conversion?
Answer 2	<i>Transport Canada (TC) will be able to guarantee a five (5) business day turn time regarding their comments in order to facilitate the French conversion. TC may also consider pushing back the due date for the draft final report to 1 week earlier in order to provide more time for the translation.</i>

Question 3	Will transport Canada provide previous data layers for the study that they might have completed?
Answer 3	<i>Transport Canada will provide any previous data layers they may have completed that they are able to share with the consultant.</i>

Question 4	Will Transport Canada provide data from USA departments or DOT i.e PHMSA?
Answer 4	<i>TC will provide data from the USA departments or DOT where available.</i>

Question 5	What's the allocated budget or level day effort that Transport Canada is estimating for this project?
Answer 5	<i>A budget has been determined however at this time it is not available to be shared with potential bidders.</i>
