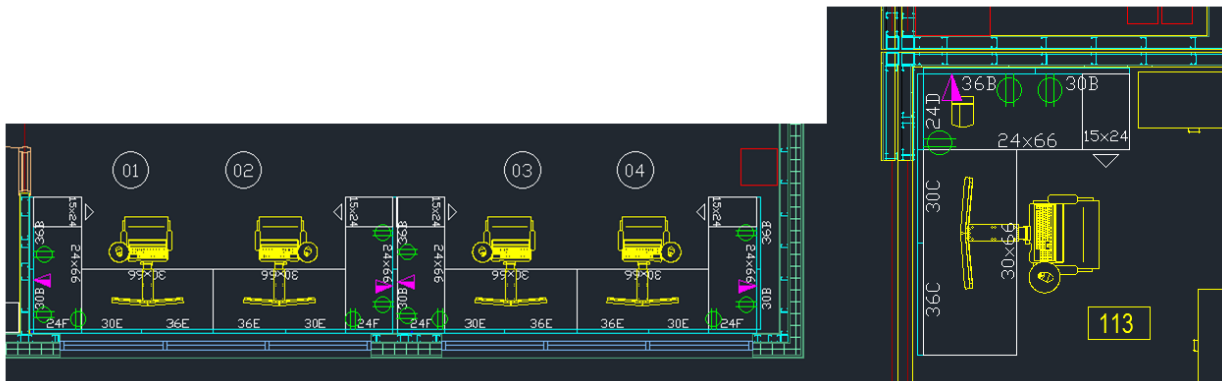

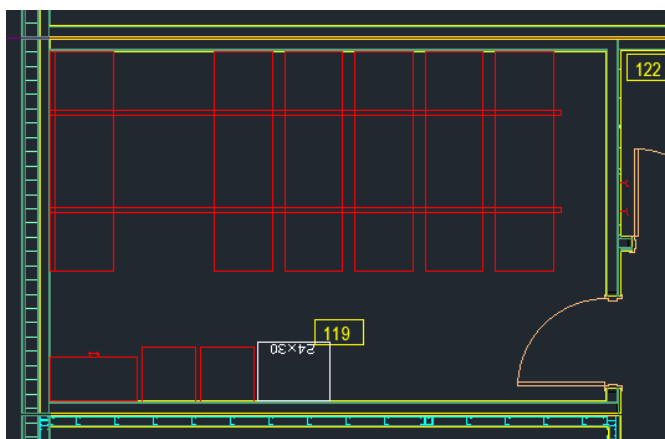
**Q1:** CAT-1B qty 5 24x66 panel mounted worksurfaces. Drawing shows only qty 4. Where's the 1 extra?

**A1:** There are 4 in 114 and 1 in 113. See below.



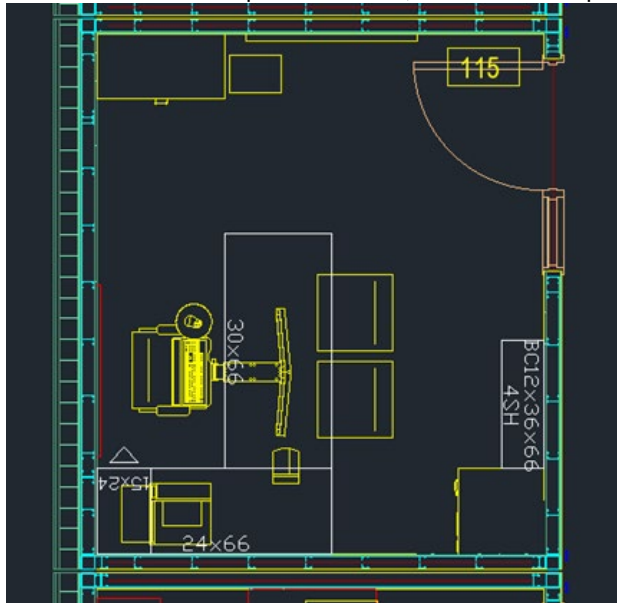
**Q2:** CAT-1B qty 1 24x30 C legs w/ modesty panel. Please provide a room tag. Can't find this in the drawing?

**Q4:** Room 118 - Are those 4 tables 24x60 to be included in the scope of work? Not in Table 1

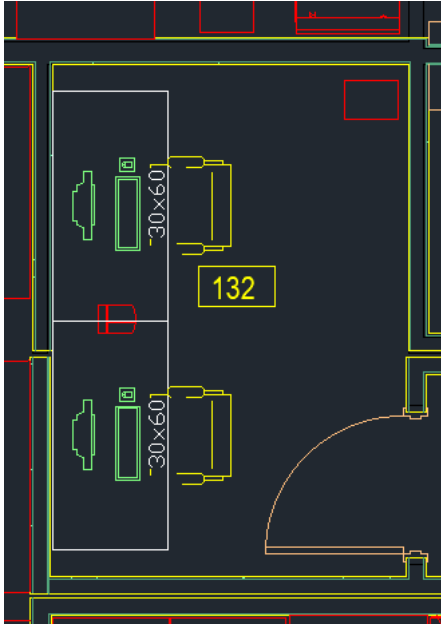

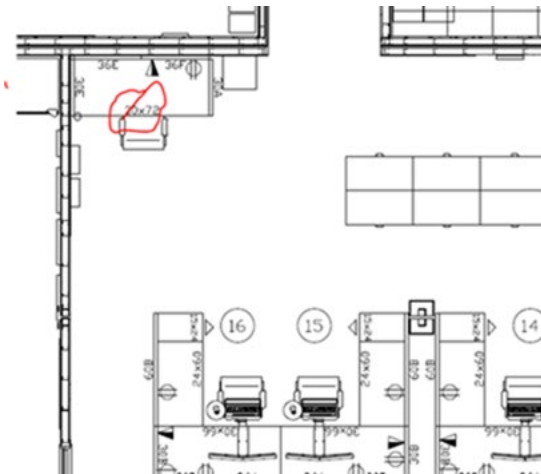
