QUESTIONS AND ANSWERS

This document includes answers to questions raised by potential bidders. It is also to advise Bidders that the Government of Canada has suspended the COVID-19 Vaccination Policy for Supplier Personnel effective June 20, 2022. Attachment 5.2: COVID19 Vaccination Requirement Certification Form is therefore no longer required.

Q2. Mandatory Criteria MC1 and MC2 require vendors to cite contracts with a value of \$6M this is an extremely high value for resource based contracts, and is inconsistent with the \$2M cited in the rated criteria RC1. In order to accommodate experienced vendors and facilitate a competitive and valuable solicitation we would like to request that the client amend MC1 and MC2 to accept contracts with a value of \$2M.

A2. The Crown is in agreement to amend MC1 and MC2 to accept contracts with a value of **\$3M**. The rated criteria RC1 is revised accordingly at section i. to replace \$2M by **\$3M**.

Q3. Reference RC1:

Please confirm that reference contracts with equivalent resource categories under a different title will be accepted, provided that the bidder demonstrates equivalency by mapping 50% of the RFP Category Tasks with a signed client attestation letter – as PSPC has accepted for past Solicitations.

A3. Yes the Crown confirms.
