Q9 I was wondering for the Crushing by Golden, BC and Fairmount hot springs, will we need special permits to operate in BC.? Will we need permits for Trucking hauling our equipment into B,C.. A9 Please refer to Commercial Transport Procedures - Province of British Columbia (gov.bc.ca).

# Questions from Ottertail, Settlers and Quartz Creek Gravel Pits

**Q10** Where are we to transport the gravel to?

A10 As per the contract the gravel is to be stored on site with the following exceptions: -

Section 01 11 00-1.3.1.4 Quartz Pit-Once produced, abrasives are required to be hauled approximately 1 km and piled adjacent to the Trans-Canada Highway as directed by Departmental Representative.

Q11 What is the schedule of work? Can we work 24 hrs a day?

A11 As per the contract work is scheduled 7 am to 7pm, 7 days a week. Section 01 14 00 1.4.1 With the following exception:

Contractor can have access to Quartz Pit 24 hours a day, 7 days a week for the duration of the work. Extensions to operating hours may be possible in other locations but we are unable to confirm any extensions at this time.

**Q12** Are we allowed to camp by the gravel pit for the crushing period?

A12 As per the contract camping is available on all 3 sites- additional information in section 01 14 00 item 1.3

**Q13** What is the deadline, project window?

# Questions from Quartz Pit

Q15 Do we need a jurisdiction notification from provincial ministry? (BC mines)

**A15** The successful bidder will be required to complete Form H1258 (2019/11) "The Sand and Gravel/ Quarry Operations Notice of Work" form which will be required to be submitted a minimum of 10 days prior to work starting. This form is attached for review and will be forwarded to the successful bidder with required details.

Q16 Are they going to build a road to bring crusher in? (Crusher won't make the corner).

A16 Parks Canada will ensure that there is adequate road access to the site for all equipment prior to work commencement

**Q17** Regarding the size of the blast rock and other rock materials hauled into the Ottertail pit west of Field Some of that Material is 450-mm in size? I would like to know from the parks authority if" the 300-mm Grizzley is acceptable.

A17 A 300mm slotted screen would be acceptable and all oversized materials to be stockpiled as per section 31 05 16 3.1.1 Pg 44 3.1
