Q2. On Vegetarian Lunch Menu 3,4, and 5 there is only a description that says Salad. Can you provide the specifications?

A2. Please refer to the amended menu in Annex B (attached)

Q3. On Page 43 (Annex A), one of the requirement is for minimum of 14 days of shelf life from the date of delivery. Given that majority of the box lunches have fresh fruit requirement, it would be an additional risk to maintain freshness of the fruits for that long period. Is there a particular operational reason to request the shelf life for that long period?

A3. Canada needs a minimum of 14 days of shelf life due to operational last minutes requirements. Many times kitchens will received Box Lunches requirements from clients for the next day. Kitchens keep Box Lunches in their fridges to meet that demands. If the sandwiches and fresh vegetables are in Gas Flushed they should keep fresh for more then 14 days.

Q4. In Annex B - Working Copy for Bidders spreadsheet, there are number of box lunches that are listed between Code Item 6M001 to 6M085 that do not have breakdown of the content of the boxes. Can you please clarify what are the specifications of these box lunches?

A4. Please refer to the amended Working Copy (attached) for Bidders. Some line items are hereby removed from the list.

Q5. In Annex B - Working Copy for Bidders spreadsheet, there are 48 line items for box lunches but there are only 30 recipes.
