This solicitation amendment is raised to :

1. Extend the solicitation period as detailed in Appendix A-4 and answer to question #13.

Question #13:

While we recognize an extension has already been granted, the fact that Saint-Jean Baptiste Day and Canada Day is in that timeframe takes away from the net impact of the extension. As a result we would like to request a further extension given the recent changes made to the resource criteria, the complexity of the bid requirements in the subject solicitation, the amount of effort required to respond, the June 24/upcoming July 1 holiday, and the volume of other Federal Government solicitations currently undergoing competition. We respectfully request a two-week extension of the closing date to allow Bidders the additional time required to reach candidates during the summer vacation season and properly substantiate the amount of detail that needs to be provided.
