Question #14:

In order to enable proponents to meet the unique requirements of this contract, would the Crown please accept foreign education credentials in response to M1, without a Canadian Equivalency assessment, provided that the Degree was granted by a British institution? The British post-secondary system is well established and highly similar to Canadian counterparts, in addition the strict timelines of this proposal submission prohibit resources from attaining a credential assessment prior to the deadline.

APPENDIX A-5

IN ATTACHMENT 4.1, MANDATORY CRITERIA – RESOURCE EVALUATION CRITERIA

At M1 for positions 1, 2 and 3, criteria are amended as follow:

REMOVE.

The Bidder must demonstrate that the proposed resource has completed a post-secondary educational program in Information Technology science, engineering, or other IT related field, from a Canadian post-secondary educational establishment, or an institution recognized by the Canadian Information Centre for International Credentials.

Proof of program completion must be provided in the bid.

ADD

The Bidder must demonstrate that the proposed resource has completed a post-secondary educational program in Information Technology science, engineering, or other IT related field, from a Canadian post-secondary educational establishment, or an institution recognized by the Canadian Information Centre for International Credentials (CICIC) **or by the Alliance of Credential Evaluation Services of Canada.(ACESC).**

Proof of program completion must be provided in the bid.

ALL OTHER TERMS AND CONDITIONS REMAINS UNCHANGED
