Item# 1

- Part#RBC132 Replacement battery cartridge for SMT1000RM2U or equivalent X 4 = this is a discontinued product.
- Part#RBC132 is a battery that goes into SMT1000RM2U, and since we discontinued SMT1000RM2U than Part#RBC132 is also discontinued.

Solution

 SMT1000RM2UC replaced SMT1000RM2U and in this case we also replaced Part# RBC132 by Part#RBC157 which is compatible with SMT1000RM2UC. The client should replace SMT1000RM2U by newer solution SMT1000RM2UC

Solution

 APC BRM1000MS replaced APC BR1000G and in this case we also replaced Part# RBC123 by Part#RBC160 which is compatible with BRM1000MS. The client should replace BR1000G by newer solution BRM1000MS
