Can the Crown please clarify how many resources a bidder is required to submit at bid deadline? Is a bidder able to submit one (1) resource at bid deadline or are three (3) resources required?

Revised Answer No 9:

Canada has amended Attachments 4.1 and 4.2 to remove the C.7 IT Security Design Specialist, level 2, position 3 from the evaluation at bid closing. Bidders must provide two (2) resources at bid closing.

Only a certain number of resources per Resource Category will be evaluated as part of this bid solicitation as identified in Attachments 4.1 and 4.2. After contract award, the Task Authorization process will be in accordance with Part 7 – Resulting Contract Clauses, the Article titled “Task Authorization”.
