This Solicitation Amendment No. six (6) is raised to include the following :

1. Answer the following questions:

**Q2.** Every floor with window sprinklers must have a separate independent zone, by code, from the floor zone sprinklers. Again can we have (1) separate zone per floor rather (4) independent zones

**A2.** The Contractor is to provide a complete and operational fire protection system in compliance with all applicable codes, standards and code consultant report, as noted on the M40 series drawings and Division 21 specifications.

**Q3.** Are all the VFD's supplied by section 23? On the points list it shows supplied by section 25.

**A3.** VFDs to be supplied by Division supplying the equipment associated with the respective VFDs. VFDs to comply with requirements noted in Specification section 23 05 14 Variable Frequency Drives. Points list will be revised accordingly as part of the Addenda 2.

**Q4.** Are all the control valves by section 25? On the Points list is shows some valves supplied by section 23. Example: Fan coils, wall fines, FPB, Force flow heater.

**A4.** All the control valves to be supplied by Division 25. Points list will be revised accordingly as part of the Addenda 2.

**Q5.** I believe you are missing the Air flow station for Exhaust fan 3 on the point list and control details. The only place it's shown is on drawings M73-04.

**A5.** Air flow station is not required for exhaust fan EF-3. M73-04 will be revised accordingly as part of the Addenda 2.

**Q6.** Reference A21-00 to A21-06- Demountable partitions -Please provide Elevations with details as to the type of demountable walls (ex: solid, glass, working walls etc.)

**A6.** Elevations are not required. There are section diagrams provided on sheet A01-07 under the Glazed screen walltypes and plan details at 3/4 A53-02. The door heights (full height) are called out in the door schedule & specification

**Q7.** Is there any problem with running the standpipe a/o combined standpipe/sprinkler risers in the stairwells?

**A7.** There are currently existing slab opening for risers in the locations shown that are being reused. There are currently no such penetrations in the existing stairs slabs nor any clear information that such penetrations will be possible. The intent is to minimize construction activity in the stairwells.

**Q8.** Would 240KA/Phase be acceptable for TVSS Unit, versus Eaton Standard of 250KA?

**A8.** 240 kA/Phase is acceptable

**Q9.** Are all accessories listed in 26 28 16.02 2.4.1 on all MCCB, or, only if indicated on drawings?

**A9.** Include additional accessories if indicated on single line diagram.

**Q10.** In the basement area around the garage door entrances you specify dry pipe system rather than wet pipe system. Why is there a need for heat tracing? Drum drips are not required to be heat traced.

**A10.** Heat tracing refers to the wet standpipe section of piping in the area, not to the dry sprinkler system. Clarification in Addenda 2

**Q11.** Is Owner's Meter for the Fire Pump required in Switchboard AAA? It is shown on Elevation Detail 4/E03-01, but not shown on SLD 1/E04-01

**A11.** Digital meter required on fire pump as per detail 4/E03-01

**Q12.** Will the building have occupants at any point during construction? a. Can work throughout the course of the project be done during the day (assuming on schedule), b. Or will night/weekend work be required (i.e. certain areas or times, etc.)? c. Will there be a phased approach?

**A12.** The building will be unoccupied during construction with the exception of any Departmental Representatives for the purposes construction administration.

**Q13.** Reference Section 10 23 26 - Glass Partition Systems- Partition Type P-3.1A notes an STC rating of 36. These same rooms in the A02-10 Series along with the Door Hardware Schedule show STC 35 ratings. Can you please clarify?

**A13.** Refer to General Note 2 on drawing A01-07

**Q14.** Reference Section 10 23 26 - Glass Partition Systems-- Partition Type P-3.1B notes an STC rating of 46. These same rooms in the A02-10 Series along with the Door Hardware Schedule show STC 45 ratings. Can you please clarify?

**A14.** Refer to General Note 2 on drawing A01-07
