Questions received as of 12 July 2022**Q1. Reference: Annex B - Basis of Payment, Table 2 (Fixed Hourly Rates)**

Can Canada explain, why the categories of E3 Specialist (positions 49, 50 and 51) and Certified TEMPEST Professional (positions 62 and 63) categories are included in Table 2 not only for Core Network but also for SoS E&I (W8486-200731/C) and ISTAR (W8486-200731/E)?

Should bidders conclude that these labour categories, and the corresponding scope of work associated with these specialists, are part of the Core Network, SoS E&I and ISTAR LC4ISR capability programs?

A1. [Yes, it is expected that these labour categories will be required for work on the contracts in question.](#)

Q2. Reference: Annex A (Statement of Work), section 5.2.1.1

The requirement states that "The Contractor must implement and manage a SEMP in accordance with the standard DLCSPM-SEP-2021DLCSPM. This document is the LAND C4ISR CAPABILITY SYSTEMS ENGINEERING PLAN (dated 14 Dec 2021) released under W8486-200731/B (LC4ISR) System. In section 4.7.6.1.c.iii.1 & 2 of DLCSPM-SEP-2021DLCSPM, the position of SEM (System Engineer Manager) is listed for the SoS E&I contractor and the Functional Grouping contractor.

Do the contractors provide the SEMs or are the SEMs provided by DLSCPM? Please clarify.

A2. [The contractor is to provide a SEM to work with the DLCSPM Chief Engineer and other senior staff to achieve the required work requirements.](#)

Q3. Reference: Annex A (Statement of Work), section 5.2.1.1

The requirement states that "The Contractor must implement and manage a SEMP in accordance with the standard DLCSPM-SEP-2021DLCSPM. This document is the LAND C4ISR CAPABILITY SYSTEMS ENGINEERING PLAN (dated 14 Dec 2021) released under W8486-200731/B (LC4ISR) System. The document DLCSPM-SEP-2021DLCSPM indicates that Section 8 (Fielding Process) and Section 9 (In-Service Support) are still to be developed.

Does Canada intend to issue an updated and final version of DLCSPM-SEP-2021 DLCSPM prior to the release of the SoS E&I RFP?

A3. [The intent is to provide an updated version of the SEP via an amendment to the RFI W8486-200731/B. Also, we plan to work with the winning bidders to develop a process that works for all organizations.](#)

Additionally, the Contractor must designate SEMs to work with DLCSPM SEMs. Please refer to SoS E&I SOW Section 5 (specifically Section 5.3.4.1)

The Contractor must designate specific personnel of its choice to advise on Land C4ISR System Engineering Manager (SEM) activities to the Contractor's SoS E&I Chief Engineer. These individuals include:

- i. Contractor's SoS SEM,
- ii. Contractor's Mobile Domain SEM,
- iii. Contractor's Headquarters Domain
