AMENDMENT 003

This amendment 003 is raised to respond to the questions received from the industry and modify the Request for a Standing Offer (RFSO) as follows:

A. QUESTIONS AND ANSWERS

Question 4:

Due to the current requirements would it be possible to provide 2 sample suits? One demonstrates the color that is required. The second suit matches the material and measurements as detailed .

Answer 4:

The Bidder may submit a pre-award sample with the main fabric being in different colours as those defined in the technical specifications. This would be accepted as a substitute to the main fabric. However, should the Bidder be awarded the contract, all materials will be strictly in accordance with the technical requirement.

Question 5:

Would the sample suits be returned?

Answer 5 :

No, the samples will not be returned.

B. MODIFICATION TO THE SOLICITATION DOCUMENTS

At section 4.1.1.1 Mandatory Technical Criteria, of the RFSO:

INSERT:

In the event that shell fabric material (as defined in Annex B, item 1) is not available to the Bidder in a time frame to manufacture the pre-award sample(s) with the required colours, the Bidder may use a similar substitute component with different colours. Also, the Bidder must include a letter explaining the substitution submitted with the pre-award sample(s), together with a statement that, should the Bidder be awarded the contract, all materials will be strictly in accordance with the technical requirement.

All other terms and conditions of the contract remain unchanged.
