It refers to these as being in Appendix 9 and Appendix 10. I believe these are Appendix 7 and Appendix 8 in the documents. Appendix 9 and Appendix 10 are not included in the documents. Can you please confirm this is correct.

A2. Yes that is correct. Under S10 Security Clearance Requirements, it should say Appendix 7 – AFR and Appendix 8 – IISS.
