Title: Accommodation Services in New York City

The Department of Foreign Affairs, Trade and Development hereby amends, in accordance with this addendum the Request for Proposals (RFP) for the provision of accommodation services, bearing number 23-222013. This addendum hereby forms part of the RFP and the purpose is to:

- 1. Answer questions related to the RFP that we received
- Make amendments to the RFP

This addendum is issued prior to receipt of bids to provide for certain revisions to and clarification of the solicitation documents.

QUESTIONS AND ANSWERS

- Q1. In Annex A Statement of Work, under point 6 b) of Specifications/ Minimum Requirements of the Units, it states that the units must be at least one-bedroom accommodations. Would Mission Procurement consider Studio accommodations of 400 sq ft or larger, otherwise featuring all outlined specifications and meeting all minimum requirements, for a significant cost savings? If so, should we offer 2 versions of Annex B? Would Mission Procurement consider a mix of studio and 1-bedroom accommodations at the same property?
- A1. Please refer to answer A2. of Addendum #1 dated July 20, 2022.
- Q2. In Annex A Statement of Work, under point 10 Cancellation policy (page 31), it refers to Annex B for Cancellation policy for less than 15 days. There is not anything in Annex B referring to a cancellation fee within 15 days' period. Please advise where and how the cancellation policy for less than 15 days have to be included with the RFP.
- A2. Please refer to Amendment # 1 to the RFP, see below.
- Q3. Annex B II Pricing Summary (Page 32) requires to state taxes and the total amount. Does Department of Foreign Affairs, Trade and Development Canada carries US Tax Exemption Certificate/Card that it intends to use to waive applicable accommodation taxes?
- A3. The Government of Canada has a tax exemption card for accommodation services and intends to use it for this contract.
- Q4. Could you kindly confirm the timeline of the RFP process and when the Department of Foreign Affairs, Trade, and Development Canada anticipate awarding the contract.
- A4. Please refer to answer A1. of Addendum #1 dated July 20, 2022.


