Q193. Limited information is provided for the scope of section 03 01 37. To properly price the work, the following information is required. Without this information the contractor cannot quantify many of the items included in the unit rate such as hoardings and protection, work platforms, sawcutting, or the effect of the work on the construction schedule.

- a. Location of the repairs.
- b. Guidance on the size of individual repair areas.
- c. Are the repairs for Type A and B only planned on the top side of slabs, or are repairs required on the underside of slabs? If so, what amount is on the underside?

c. Unit price for underslab repairs is added in NORR Addendum 6.

Q194. There appears to be a discrepancy between the number of Acoustic Panels on the schedule on Drawing A51-11 and the physical count on the elevations on drawing A32-00. Please clarify which quantity we should use.

A194. Use the number from the schedule on Drawing A51-11 - angled walls with acoustic panels are shown more than once on adjacent elevations

Q195. Can you provide information on the size of the underground fuel tank to be removed? this is necessary to determine the size of equipment needed to remove the tank.

A195. Existing documents show this as a 20,000L fuel oil tank Tank ID 2520317-72-G02-1
