#### **Amendment 001**

Solicitation amendment 001 is raised to answer questions raised from Industry and amend the Request for Proposal (RFP).

#### Q1.

The description of Work Package E looks like that of the First Officer (Work Package A) rather than Acceptance Pilot.

#### A1.

Yes, the text in Work Package E is meant to resemble Work Package A. Work Package E grooms the pilots for aircraft acceptance roles and responsibilities, whereas Work Package A provides First Officer type rating training. The trainees background/experience will be different for each work package.

#### Q2.

Would Canada consider a flight simulator with a different Flight Management System (FMS) configuration (Honeywell instead of Thales)?

#### A2.

No. Canada will only accept a Full Flight Simulator which has a Thales FMS.

#### Q3.

Can Canada clarify the make/model information of specific equipment for specific systems within the cockpit (e.g. Make/model of Flight Management System, Radios, etc)?

#### A3.

The A330-200 aircraft are Airbus Standard Specification Issue 5.2 and have the following cockpit equipment:
