The amendment to the bid solicitation is to address the enquiries received:

Q1: On the scope of work for electrical. It provides a list of all the material the government will supply. I'm wondering about the instrumentation junction box as to who is supplying it. I do not see any specs on the size of junction box or if it will be supplied by government?

A1: The Instrument junction box which houses the datalogger and where signal cables are terminated is provided by ECCC/Government. It has been procured and populated and is ready for the installation. ECCC will mount as needed.

Q2: The bidders scope of work is to provide a 100a weatherproof panel with breakers and all other material is supplied by government?

A2: The contractor is to provide a 100a weatherproof panel with breakers, all other materials is supplied by Government/ECCC, including cables/junction boxes/terminals etc.

Q3: Who is to terminate the control cable at each weather station?

A3: ECCC/Government Technicians will terminate all control/signal cable utilized for all the sensors at the weather station. The contractor will terminate power cables as per Statement of Work and the Canadian Electrical Code.
