- 2) provide oKtopure High Throughput DNA Extraction Robot Premier Service Contract (IR-04728), 1 year, covering all repair costs (parts, labour and on-site travel), including one preventative maintenance, with option to renew Service Agreement for additional two years (maximum total contract 3 years).

Any interested supplier must demonstrate by way of a statement of capabilities that it meets the following requirements:

You are hereby notified that the government intends to negotiate with one firm only as identified above. Should you have any questions concerning this requirement, contact the Contracting Authority.

An Advance Contract Award Notice (ACAN) allows departments and agencies to post a notice, for no less than fifteen (15) calendar days, indicating to the supplier community that it intends to award a good, service

or construction contract to a pre-identified contractor. If no other supplier submits, on or before the closing date, a Statement of Capabilities that meets the requirements set out in the ACAN, the Contracting Authority may then proceed with the award. However, should a Statement of Capabilities be found to meet the requirements set out in the ACAN, then the Contracting Authority will proceed to a full tendering process.
