1. QUESTION AND ANSWER

- Q1.** Can we submit a proposal for only one location: Quebec, Shawinigan-Sud? We are interested in bidding to provide services in this location only.
- A1.** No, bids for single locations within a service area will not be accepted. A bid must be submitted for the entire service area, as specified in the RFP (Eastern, Central, Prairies and Pacific). Bidders can bid on more than one service area.

2. AMENDMENTS TO THE RFP

- M1.** At Part 1 General Information, section 1.2 Summary:

DELETE:

The CRA requires the services referenced above in the following regions:

Eastern:

This region comprises the provinces of Quebec, excluding the National Capital Region, New Brunswick, Nova Scotia, Prince Edward Island, and Newfoundland.

Central:

This region comprises of the province of Ontario and the National Capital Region.

Prairies:

This region comprises of the provinces of Manitoba, Saskatchewan and Alberta.

Pacific:

This region comprises the province of British Columbia

Up to four contracts may be awarded as a result of this bid solicitation.

Bidders may submit a proposal for any of the four regions. Bidders can bid on more than one region. In the event that a single Bidder is deemed the highest ranked responsive bid for multiple regions, the CRA will award one contract for these multiple regions.



INSERT:

The CRA requires the services referenced above in the following service areas:

Eastern:

This service area comprises the provinces of New Brunswick, Nova Scotia, Prince Edward Island, Newfoundland and Labrador, and Quebec (excluding the National Capital Region (NCR)).

Central:

This service area comprises of the province of Ontario and the NCR.

Prairies:

This service area comprises of the provinces of Manitoba, Saskatchewan and Alberta.

Pacific:

This service area comprises of the province of British Columbia.

Up to four contracts may be awarded as a result of this bid solicitation.

Bidders may submit a proposal for any of the four service areas. Bidders can bid on more than one service area. In the event that a single Bidder is deemed the highest ranked responsive bid for multiple service areas, the CRA will award one contract for these multiple service areas.

M2. At Annex A: Statement of Work, section 4.2 Regional Information:

DELETE:

INSERT:

Eastern: the provinces of New Brunswick, Nova Scotia, Prince Edward Island, Newfoundland and Labrador, and Quebec (excluding the National Capital Region (NCR)).

M3. With the exception of Annex A: Statement of Work, section 4.0 Scope where mention is made of existing regional contracts and CRA regional information, any other mention of 'region' is substituted with 'service area'. This change will be reflected in the eventual contract(s).
