Q1: Please provide Appendix A – Environmental Documents for contractors’ review and consideration in preparing pricing for this tender submittal.

Q2: The Specification is calling for “Chromate Treatment” for the reinforcement bars. Please confirm if this treatment is required?

A2: Refer to Amendment #1

Q3: With respect to Section 01 11 00 - 1.11.3 “Work Schedule”; please clarify the final completion date of August 31, 2022?

A3: Refer to Amendment #1

Q4: With respect to Section 10 11 00 - 1.13.1 “Sanitary Services”; “The Contractor shall provide and maintain sanitary facilities for the use of workers at locations specified by the Departmental Representative.” Please clarify where these locations will be?

A4: Refer to Specifications Revisions #1

Q5: With respect to Section 01 29 10 - 1.2 10 “Other Items Not Included in the Unit Price Table”; Please clarify as Item #10 is missing from the Lump Sum Table A.

- A5:** Publication error. Please see “Amendment #2 – Revised Annex 1 – 2022/08/18.
- Q6:** With respect to Section 01 29 10, 7.2 “Temporary Panel Bridge”; please provide a current parts listing for the bridge to be constructed. This listing will enable contractor to account for missing/absent parts required for the bridge assembly.
- A6:** Unfortunately, no parts inventory list is available. It can be presumed all parts for the temporary bridge are obtainable.
- Q7:** With reference to Section 01 35 43 - 1.8.1 “Site Clearing & Plant Protection”, please provide details and costs related to obtaining a restricted activity permit.
- A7:** Contractor shall abide to the BIA for the project. Written asks for restricted activities must be submitted to Gros Morne National Park’s Resource Conservation Division for approval.
- All permits through PCA are free of charge.
- Q8:** Section 01 11 00 - 1.23 “Permits/Authorities”, please provide a listing and applicable fees for all required permits to be obtained from authorities.
- A8:** Contractor responsible for all permits from provincial authorities and utilities.
- Q9:** Please confirm if the launching nose for the temporary bridge is included and is located in Rocky Harbour, NL.
- A9:** Bridge is located at GMNP’s compound within Rocky Harbour, NL - 3 DOT Drive.
- Q10:** Please confirm details, finishes and materials required to be used in the construction of the decorative barrier railing.
- A10:** All information is provided in the drawings and specification. There is a specific section in the project specification dedicated to the metal railings for structures.
- Q11:** Section 13 35 00 - 3.1.5 “Manufacturer’s Representative – Panel Bridge”, contractor understands they are to coordinate all site visits as required by the Manufacturer’s Representative. Please clarify who will be responsible for payment for the services of the Manufacturer’s Representative.
- A11:** The contractor will be responsible for payment of the services from the Manufacturer Representative.
- Q12:** Can the Owner provide any further information/details for the existing bridge (ie. size of girders, abutment & pier dimensions, elevations, etc.).
- A12:** Existing bridge details are unavailable. Contractor is recommended to visit site prior to bidding.
- Q13:** Contractor is asking for a change to the closing date, we are requesting the closing date be revised to August 31, 2022.
- A13:** No extension to the closing date is warranted at this time. Closing date to remain as August 23, 2022.

ALL OTHER TERMS AND CONDITIONS REMAIN UNCHANGED.
