N*	Questions	Responses
1	Cat 1B, Items 1 & 2 - i) Please identify which tables in Cat 2 each line item is to be installed on, the quantities do not align. ii) If they are to be installed on the 48" and 54" Cat 2 tables then these sizes will be nominal per SA requirement, so if we use exact sizing as requested they will extend past the length of the surface. Please confirm nominal sizing is to be maintained.	The Items 1 Cat1B are to be installed on the Cat2 sit-stand tables (Item 3&4). Item 1 (Cat1B) is for the 48" sit-stand tables (Cat2 Item3) and for R1 - the 54" sit-stand tables (Cat2 Item4). Numbers of Cat1B Item 1 and Cat2 item 3&4 do not fit as there is some sit-stand table against wall. Those against the wall do not need a fabric panel. The Item 2 of Cat1B are Frosted glass panel, as described in the description of item 2 (Cat1B). These panels are to be fixed on the Cat2 Item 1&2. Again with these panels, the number of Item 2 (Cat1B) and Items 1&2 (Cat2) do not fit as the tables against wall do not need panel.
2	Cat 1B, Item 4 - This does not appear to be a current GoCUID from the current SA, please advise.	Yes this item is in Cat1A.
3	Will the shipping location be able to accommodate a 53 ft trailer? If not, what is the max. truck length the location is able to accommodate?	Max 35ft trailer. Note: access to the building is through the main entrance on the first floor (double door). No loading dock or reception area.
4	We noticed there is no freight elevator. Will stair carry be required?	The building does not have a freight elevator, although, we have 2 conventional elevators with a maximum capacity of 1135kg/lift. Elevator doors: 3½ by 7 feet.
5	What is the height of the ceiling (for the columns)?	8 feet
6	CATEGORY 1 - ITEM #4 BHNPxxxxxFxxxxFxxxxxxxxxxxx48 – Can you please confirm this code?	This item is in Category 1A. The code has been verify and it is accurate.
7	Item 2 of category 1 of the <b>table in French</b> mentions: Fabric privacy partition, or a frosted glass privacy partition.	Frosted glass privacy partition (in the descriptions section, the information is correct).
