Amendment 001 has been raised to answer the following questions:

Q1E – The scope of work does not include grading and back filling the lot once demolition is complete. Is this required?

A1E – The building is assumed to be supported on blocks. There is no requirement to regrade the site, after all debris is removed.

Q2E – The Environmental Site Assessment states that no hazardous materials were found to be present, other than mould. Was the ground tested and does any soil need to be removed and replaced?

A2E – A level 2 Environmental Site Assessment will be completed after the building is removed, in order to determine if there is any ground contamination. The contract scope does not include any soils removal at this time.

Due to the impacts of the COVID-19 pandemic and to encourage physical distancing, the bid receiving unit in Edmonton will remain open but with limited staff and limited hours: Monday and Thursday 9 am to 11 am and Tuesday 9 am to 2 pm (local time).

Public tender openings will be suspended until further notice. Following solicitation closing, bid results will be recorded and may be obtained by e-mailing a request to the address indicated in the Invitation to Tender.
