### B. Questions and Answers

**Q1** Does the ceiling height in the Big House remain the same as the original height?

**A1** The ceiling height will remain the same.

**Q2** Areas of the dry walled ceiling are missing in the basement in Room B 3. Is the entire ceiling required to be replaced in the basement of Big House in room B3?

**A2** The contractor is required to patch the missing areas in room B3 as directed in specs package.

### C. Clarifications

- PCA indicated that in case of swift bird nesting at Furloft, that may impact the work schedule - Low risk.
- PCA indicated that a list of items (supplies and material) will be supplied by PCA, listed in specs and drawings.
- PCA showed bidders the links to the DSP attachments which show that there were 3 buildings.

- Clarified that in addition to fire protection repairs required for all the buildings specifically the architectural repairs were required in the Big House not the other buildings. The drawings for the architectural package and electrical package are only the Big House.
- PCA indicated that artifacts are still in the buildings and the contractor is not to move them. If they need moving the contractor must contact the project managers.
