1. QUESTIONS AND ANSWERS

- Q10.** The schedule in Appendix 1 shows classes beginning on the following dates- Dec 19, Dec 26, Jan 02-2023. These dates are generally not considered for contactors to do work because of the amount of people away on holiday vacations. Is it safe to plan that there will be a three-week hiatus to the programs from Dec 19 to Jan 12?
- A10.** The plan was shared to provide bidders with a general sense of what we would like the training plan to look like. The dates will change to accommodate the actual start of the program and yes, it is safe to plan that there will be a three-week hiatus for the weeks mentioned.
- Q11.** In Annex B: Basis of Payment there is no mention as to the frequency of payment. What is the expectation of the Contractor to invoice CRA. Is it a standard monthly amount, or by program completion per month?
- A11.** The CRA will pay the Contractor upon completion and delivery of trainings on a monthly basis.
