IMPORTANT NOTICE

This bid solicitation cancels and supersedes previous bid solicitation number 5000067016 dated 2022/06/06 with a closing of 2022/07/07 at 18:00 EDT. A debriefing or feedback session will be provided upon request to bidders/offerors/suppliers who bid on the previous solicitation.

TWO PHASE SELECTION PROCESS

This is the first phase (Phase One) of a two-phase process: the first phase will evaluate the qualifications of all interested respondents; the second phase (Phase Two) will invite the qualified respondents to provide a financial bid on the project based on the specifications and drawings. The qualification list will expire upon award of a contract in Phase Two and the prequalification list will not be used in any other solicitation.

DEBRIEFING:

Should a respondent desire a debriefing, the respondent should contact the person identified as the Contracting Authority below within 15 working days of the notification of the results of the qualification process. The confidentiality of information relating to other submissions will be protected. The debriefing may be provided in writing, by telephone or in person.

LIST OF QUALIFIED RESPONDENTS:

A list of qualified respondents from Phase One will be released in Phase Two to all qualified respondents at time of solicitation. Contract award notice of the successful bidder of Phase Two will be posted on buyandsell.gc.ca

INSTRUCTIONS TO RESPONDENTS

1. TWO PHASE SELECTION PROCESS

Respondents responding to this selection process are requested to submit in two phases. Phase One qualification covers only the qualifications and experience of the respondent. Following the evaluation of the responses, respondents will be advised of their qualification result and the status of the Phase Two tender. Phase Two respondents will be provided an Invitation to Tender (ITT) for the financial evaluation in relation to the specifications and drawings.

Documents may be submitted in either official language of Canada.

3. SUBMISSION OF QUALIFICATIONS

1. Electronic Response Submission by CPC Connect Service

- a. Responses must be submitted by using the Canada Post Corporation's (CPC) Connect service provided by. Faxed and hard copy responses (submitted in person or via mail/courier) will not be accepted for the subject solicitation.
- b. The only acceptable email address to use with CPC Connect for responses to solicitations issued by PWGSC is:

Note: Responses emailed directly to this email address will be rejected and deemed non-compliant. This email address is to be used to open a CPC Connect conversation, as detailed in c., or to send proposals through a CPC Connect message if the respondent is using its own licensing agreement for CPC Connect.

- c. To submit a response using CPC Connect service, the respondent must either:
 - i. send directly its response only to the specified PWGSC Bid Receiving Unit, using its own licensing agreement for CPC Connect; or
 - ii. send as early as possible, and in any case, at least six business days prior to the solicitation closing date and time, (in order to ensure a response), an email that includes the response solicitation number to the specified PWGSC Bid Receiving Unit requesting to open a CPC Connect conversation. Requests to open a CPC Connect conversation received after that time may not be answered.
- d. If the respondent sends an email requesting CPC Connect service to the specified Bid Receiving Unit in the bid solicitation, an officer of the Bid Receiving Unit will then initiate a CPC Connect conversation. The CPC Connect conversation will create an email notification from Canada Post Corporation prompting the Bidder to access and action the message within the conversation. The

respondent will then be able to transmit its response afterward at any time prior to the solicitation closing date and time.

- e. If the respondent is using its own licensing agreement to send its response, the respondent must keep the CPC Connect conversation open until at least thirty (30) business days after the solicitation closing date and time.
- f. The bid solicitation number should be identified in the CPC Connect message field of all electronic transfers.
- g. It should be noted that the use of CPC Connect service requires a Canadian mailing address. Should a respondent not have a Canadian mailing address, they may use the Bid Receiving Unit address specified in the solicitation in order to register for the CPC Connect service.
- h. For responses transmitted by CPC Connect service, Canada will not be responsible for any failure attributable to the transmission or receipt of the response including, but not limited to, the following:
 - i. receipt of a garbled, corrupted or incomplete response;
 - ii. availability or condition of the CPC Connect service;
 - iii. incompatibility between the sending and receiving equipment;

6. JOINT VENTURES

1. A joint venture is an association of two or more parties who combine their money, property, knowledge, expertise or other resources in a single joint business enterprise, sometimes referred as a consortium, to bid together on a requirement. Respondents who bid as a joint venture must indicate clearly that it is a joint venture and provide the following information:
 - a. the name of each member of the joint venture;
 - b. the Procurement Business Number of each member of the joint venture, if applicable;
 - c. the name of the representative of the joint venture, i.e. the member chosen by the other members to act on their behalf, if applicable;
 - d. the name of the joint venture, if applicable.
2. If the information is not clearly provided in the bid, the respondent must provide the information on request from the Contracting Authority.
3. The bid and any resulting contract must be signed by all the members of the joint venture unless one member has been appointed to act on behalf of all members of the joint venture. The Contracting Authority may, at any time, require each member of the joint venture to confirm that the representative has been appointed with full authority to act as its representative for the purposes of the bid solicitation and any resulting contract. If a contract is awarded to a joint venture, all members of the joint venture will be jointly and severally or solidarily liable for the performance of any resulting contract.

7. LIMITATION OF SUBMISSIONS

1. A respondent may not submit more than one bid. This limitation also applies to the persons or entities in the case of a joint venture. If more than one bid is received from a respondent (or, in the case of a joint venture, from the persons or entities), all such bids shall be rejected and no further consideration shall be given.
2. A joint venture is defined as an association of two or more parties which combine their money, property, knowledge, skills, time or other resources in a joint business enterprise agreeing to share the profits and the losses and each having some degree of control over the enterprise.
3. An arrangement whereby Canada contracts directly with a Contractor who may retain subcontractors to perform portions of the services is not a joint venture arrangement. A Subcontractor may, therefore, be proposed as part of the bidder team by more than one respondent. The respondent warrants that it has written permission from such Subcontractors to propose their services in relation to the services to be performed.
4. Notwithstanding paragraph 3. above, in order to avoid any conflict of interest, or any perception of conflict of interest, a respondent shall not include in its submission another respondent as a member of its team, as a Subcontractor.
5. Any joint venture entered into for the provision of professional services or other services must be in full compliance with the requirements of any provincial or territorial law pertaining thereto in the Province or Territory in which the project is located.

PHASE ONE QUALIFICATION FORM

PROJECT DESCRIPTION:

Environment and Climate Change Canada (ECCC) is preparing to install a new Weather Radar station near Sechelt, British Columbia. The site is located at the top of Halfmoon Peak and is accessed via an existing forest service road.

A recent on-site assessment of the access road identified several areas of concern for passage of the construction machinery required to build the Weather Radar station, as well as the need to create a cleared and graded construction area, with laydown space, for the station construction.

The Statement of Work (SOW) describes requirements for the following two key objectives:

- 1) Preparation of the site gravel laydown area (approx. 35m x 40m) including tree cutting, reduction of bedrock level by ~300 mm, grade, and gravel to ensure the crane can operate and steel can be offloaded safely on a flat laydown area (constant ASL elevation); and
- 2) Road rehabilitation to allow for safe passage of heavy-duty vehicles, such as a 42ft trailer, flat bed, 110 tonne crane, etc., ascending and descending the mountain from the entrance of R15528 TELUS Road to the specified radar location, a distance of approximately 3,500m.

The Work under this Contract consists of clearing, access road, drainage and site grading improvements for Environment And Climate Change Canada (ECCC), hereinafter called the Owner.

The Work includes the following components:

- .1 Trimming, cutting and off-site disposal for non-merchantable vegetation along approx. 3,500m in length to establish a general corridor 6m in width and 5m high.
- .2 Select cutting and stockpiling of merchantable timber as identified on the Contract Drawings.
- .3 Installation or extension of 24m - 450mm diameter culverts, min. 8m long.
- .4 Supply, place and compact a granular overlay on the existing access road to 4.0m wide width, materials and approximate lengths as identified in the Contract Drawings to ensure a road travel speed of 15km/hr.
- .5 Roadway modifications and site pad construction including removal of rock, excavation, subgrade and embankment preparation, road structure, drainage, road and embankment surfacing and hydroseeding.

The Contractor must perform and complete the Work within 10 weeks from the date of notification of acceptance of the offer.

CONDITIONS TO QUALIFY:

At Phase One closing, the respondent must:

- a) comply with the following Mandatory Requirements; and
- b) provide the necessary documentation to support compliance.

Mandatory Requirements:

Failure by the respondent to provide the required documentation in Phase One will result in the respondent being disqualified and no further consideration will be given to the respondent and the submission will be deemed non-responsive.

BASIS OF QUALIFICATION:

A qualification submission must comply with the mandatory requirements to be declared responsive in Phase One. Responding "no" to any of the mandatory requirements below will render your bid non-compliant and no further consideration will be given to the bid.

QUALIFICATION FORM

Reference(s) will be contacted for confirmation of the information submitted. If the references cannot confirm the information submitted, the response will be deemed non-compliant and no further consideration will be given to the responsive. 
