<b>Question 1</b>	Are the Strategic and General resources required to have 15 and 10 years' experience, or 8 and 3 years' respectively?
<b>Answer 1</b>	Please refer to Solicitation W6369-22-A062, Attachment 1 of part 4 – Evaluation Criteria for the various experience requirements for both the Strategic and General resources.
<b>Question 2</b>	Can you please confirm that "Medical Products" can also include biologics, nutritional supplements, non-prescription (OTC) health products?
<b>Answer 2</b>	Medical products only includes Drugs and Medical devices. Biologics are drugs, so are included in the definition of Medical Products. Nutritional supplements and non-prescription health products are not included in the definition of Medical Products.
<b>Question 3</b>	For qualifying accredited universities outside of Canada; can you please confirm whether a US/North American degree is equivalent, or if a credentials assessment is required?
