### **Amendment 003**

This amendment is raised to provide questions and answers.

#### **1.0 Questions and Answers**

Q1. We are looking to get approval for the 1.5" snaplock profile for the install on the Ingonish washrooms. I am also attaching the information on the PVDF as well. They also do have 5 other profiles if this isn't approved.

A1. 1.5" Profile is acceptable provided that the product meets all the requirements listed in Volume 01 specifications 07.61.00, 07.46.19 and related sections. Fastening to allow for thermal expansion with proposed dark color and sub-structure. Color to be approved by Department Representative and Architect at sample submission.

Q2. Looking to clarify the size and finish of the kerdi-line drain as listed on spec sheet section 09 30 13 tiling page 6 of 11 point 2.7 membranes for showers. Also, we can supply Kerdi-Board [so long as it is in stock, in other projects we have had to provide cement board due to supply shortages] and Kerdi-Line drain but would they need to be installed by other unionized trades (as indicated by note to co-ordinate with other trades)?

A2. Shower drains to be circular as shown in Mechanical and Architectural documents. Drains to be compatible with all membranes and flooring to provide waterproof condition in showers. Basis of Design for acceptable product performance is KERDI-DRAIN or similar that is compatible. Not required to be installed by other trades
