2.4. Applicable Laws


STATEMENT OF WORK

1.0 Introduction

Parks Canada requires the rental of Golf Carts for the 2023 season at Fundy National Park Golf Course, with two option years: 2024 and 2025.

2.0 Background

Fundy National Park (FNP) is located next to Alma, NB. Golf course operations require a variety of Golf Course equipment. Carts are rented from a supplier, and then rented by golfers for their use on the course. The course is open from the Friday of the long weekend in May, to the Monday after Thanksgiving in October.



3.0 Objective

Parks Canada intends to rent 22 electric power golf carts and chargers for the 2023 season, with option years for the 2024, and 2025 seasons.

4.0 Requirements

- The golf carts must be able to comfortably seat two passengers and have room for golf bags
- Must be electrically powered
- Must be equipped with non-marking tires
- Equipment must be delivered to and picked up from Fundy National Park Golf Course by supplier.
- Carts must have a canopy
