The quotation must be separated as requested below.

- **Main Work**
The main work consists of replacing the sections of damaged asphalt on VITTORIA STREET identified at the job showing. The basic quotation must include the removal of 2 layers of existing asphalt.
- **Option 1**
A separate quote must be provided in case a 3rd layers if found on VITTORIA STREET. The option 1 must includes the removal of the 3rd layer of asphalt and the backfilling of grade to keep the same finish level.
- **Option 2**
Option 2 consists of replacing the sections of damaged asphalt on BANK STREET identified at the job showing. The quotation must include the removal of 2 layers of existing asphalt.
- **Option 3**
A separate quote must be provided in case a 3rd layers if found on BANK STREET. The option 3 must includes the removal of the 3rd layer of asphalt and the backfilling of grade to keep the same finish level
- **Option 4**
A separate quote must be provided to repair a linear meter of crack in existing asphalt. Approximately 300 linear meters must be repaired. As showed and discussed at the job showing.
