SOLICITATION AMENDMENT # 002

This solicitation amendment is raised to:

1. Address the following questions submitted during the solicitation period as per RFP;
2. Revise the Applicable Laws; and,
3. Extend the closing date of the RFP.

1. QUESTIONS AND ANSWERS

Q1. Sections 2.5 and 2.6 (Applicable Laws SACC A9070T and Terms and Conditions, respectively)

Canada has very specific Privacy Laws which make contracting for this data a legal challenge. Since you are obtaining US public record data, we would want to contract based on US laws for use of our data with our terms and conditions. Specifically legal jurisdiction and governing law. US law allows for distribution and use of public record while Canadian Privacy Laws seem to prohibit its use. Our legal counsel will not approve a response unless we can contract using our US contract, governed by US law. Is that acceptable?

A1. The purpose of this RFP is to award a contract using Canada Revenue Agency (CRA) terms and conditions. CRA will not sign vendor terms and conditions.

CRA engaged legal counsel to respond to the question pertaining to jurisdiction and governing law. Please see Section 2 – Amendments to the RFP, below.

Q2. In Appendix 1: Mandatory Criteria, #M3, CRA is requesting Monthly updates to Current Bulk Data. Would annual updates suffice?

A2. No. We require monthly updates.

2. AMENDMENTS TO THE RFP

A. At 2.5 Applicable Laws SACC A9070T (2014-06-26)

DELETE:

Any resulting contract shall be interpreted and governed, and the relations between the parties determined, by the laws in force in Ontario.

The Bidder may, at its discretion, substitute the applicable laws of a Canadian province or territory of its choice without affecting the validity of its bid, by deleting the name of the Canadian province or



territory specified and inserting the name of the Canadian province or territory of its choice. If no change is made, it acknowledges that the applicable laws specified are acceptable to the Bidder.

INSERT:

Save and except with respect to the collection by the bidder of personal information in the United States and disclosure of such information to Canada which collection and disclosure shall be governed in accordance with the applicable American laws, any resulting contract shall be interpreted and governed, and the relations between the parties determined, by the laws in force in Ontario.

The Bidder may, at its discretion, substitute the applicable laws of a Canadian province or territory of its choice without affecting the validity of its bid, by deleting the name of the Canadian province or territory specified and inserting the name of the Canadian province or territory of its choice. If no change is made, it acknowledges that the applicable laws specified are acceptable to the Bidder.”

B. At 6.18 Applicable Laws SACC A9070C (2014-06-26)

DELETE:

The Contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in Ontario.

INSERT:

Save and except with respect to the collection by the Contractor of personal information in the United States and disclosure of such information to Canada which collection and disclosure shall be governed in accordance with the applicable American laws, the Contract shall be interpreted and governed, and the relations between the parties determined, by the laws in force in Ontario.
