**Bidder Questions:**

**Question 1:**

We are looking to confirm that the areas on the Jetty to be cleared, are areas bidders can access and perform snow removal services with their equipment. Should bidders encounter obstacles in their way, namely equipment, containers, cranes, welders, stored equipment, electrical wires, or other contractors working on site, are bidders only responsible to service the areas they have access to and would they be expected to come back multiple times to remove snow in the obstructed areas?

**Answer 1:**

Unfortunately, we are not the only occupants of this facility, therefore we only have so much control of how things operate on the Jetty. If we are expecting a major snowfall we will make every attempt to have the Jetty cleared from obstruction but there will be times that you will have to come back throughout the day once the obstruction is moved. This is mainly due to Coast Guard Ships schedule.
