Amendment 002 has been raised to answer question(s) received from industry and to make changes to the Request for Proposal as follows:

A. TO ANSWER QUESTION(S) RECEIVED FROM INDUSTRY

Question(s)/Answer(s)

Q3. The RFP required electrical certifications for the MidNite product (MNBCB-1000/100). Following is the manufacturer's response to providing at least one of the required certifications:

This product has not been evaluated by a listing agency such as UL, ETL, CSA etc. This means that the documentation you are requesting such as an ATM does not exist.

If there is no such certification available, would you please clarify how the bid proposal can remain responsive?

A3. The listed part Section 4 – (1000A DC Combiner with 100mV Shunt) of Item M2 - mandatory technical evaluation criteria is deleted. Please see modification to the Annex A – Part 2.1 below.

Q4. With reference to Annex A, Item 4, MidNite Solar, MNBCB-1000/100

The OEM (MidNite Solar) confirmed this product currently has no CSA certification, so it is not possible to insert the certification in our bid before closing date. The only possible way is to get the certification once the production is complete at our office locally and then ship the goods to the end user. Will Canada accept submitting CSA certification of this particular item before delivery of the order to technical authority since there is no chance to submit it with the bid?

A4. Please refer to answer # A3.

Q5. Current lead time of the requested parts is about 12 weeks ARO. Considering the fact that it is not clear when the contract will be awarded to the successful winner, delivery before November 25, 2022 cannot be guaranteed. Will Canada accept delivery of 12 weeks ARO?
