Q.5

Would RCMP allow any consideration for pressure variation beyond a max average pressure of 37,800 psi at the non-ambient temperatures?

For reference, similar frangible contracts of this nature allow for up to $\pm 9,430$ psi of variation between the extreme temperature tests from the ambient average. Would this be something RCMP is willing to consider?

No, the RCMP will not allow the maximum average pressure to exceed 37,800 psi at non-ambient temperatures."

Q.6

Would a two week extension to the 12 October, 2022 closing date be considered/granted?

Yes, Canada agrees to extend the closing date to 26 October, 2022 – Eastern Daylight Saving Time (EDT).
