- Submission 2: Price: Only those submissions from Bidders that meet the mandatory requirements of Appendix 3 – Qualification Form will be evaluated.
- Bids must be submitted to either the bid receiving email address or fax number identified on the front page of the ITT. Bids cannot be submitted directly to the Contracting Authority email address.

D. QUESTIONS AND ANSWERS

Q1: Will the contractor be able to access both helipads that have been constructed by Parks Canada?

A1: Yes – both helipads can be used – however the condition of the helipads must be similar or in better condition upon project completion.

Q2: Will Parks Canada complete the fish salvage during the project?

A2: Yes – fish salvage will be done within the identified exclusion zone. This work will be coordinated with Parks Canada upon project award.

Q3: Can the contractor store explosives on site?

A3: Since public access to the site will be restricted due to a Restricted Activity Permit and the site is remote it is possible to store explosives as long as it is in a suitable manner adhering to relevant laws and regulations.

Q4: Will as-builts be required after the work is completed?

A4: These will not be required – however surveys will be required to determine the amount of rock that was removed to address the payment requirements within the contract.

Q5: Is the contractor able to remove trees and debris within the stream if found to be impeding work?

A5: Yes – however any impacts on the existing site and vegetation must be discussed and agreed to by the Departmental Representative prior to completing the work. It must be done in compliance to the environmental mitigations outlined within the specifications.

Q6: Will Parks Canada be supplying helicopters to site for the project?

A6: No. It is the contractor's responsibility for their own access to site and project related activities. Contractors may use the staging area at Mosquito Creek and the two helipads located on site. This must be coordinated with the Departmental Representative.

Q7: Is the design cost of the project able to be provided to bidders?

A7: No. However, for bonding purposes the project has been identified as being within \$100,000 to \$250,000.

Q8: If a contractor does not attend the helicopter site visit on September 13 are they excluded from bidding?

A8: No – all contractors that have attended the mandatory bidder's conference on September 8 are eligible for bidding.
