1. Provide clarification and answers to questions from potential suppliers.

**QUESTIONS AND ANSWERS:**

<b>Question 1</b>	Is it mandatory to provide the equivalent of four resources or could the contract be awarded to more than one firm, thereby modulating the resource requirements according to the task?
<b>Answer 1</b>	The intention of this solicitation is to award one (1) contract for one (1) resource at bid closing. Up to an additional three (3) resources may be required after contract award and will be determined by the Technical Authority on an “as and when required” basis throughout the duration of the Contract.
<b>Question 2</b>	R2: Can the certification be offset by the resource’s practical experience?
<b>Answer 2</b>	DND has reviewed the question and the solicitation will remain unchanged.
<b>Question 3</b>	R4: As with the R2 criteria, can the certification be offset by project management experience? (E.g. person responsible for project managing the biomedical engineering component as part of the construction of a university hospital centre).
<b>Answer 3</b>	DND has reviewed the question and the solicitation will remain unchanged.
<b>Question 4</b>	Do vendors need to submit all 4 resources or are we allowed to submit one?
<b>Answer 4</b>	See Answer 1.
